PAYMENT POLICY: A \$600 non-refundable deposit is required to be submitted with each completed registration form.
The next 3 payments will be due as follows: 25% of total cost is due by Nov. 1, 2026; 60% of total cost is due by Feb. 1, 2027;
remainder of total cost is due by May 1, 2027.

CANCELLATION / REFUND POLICIES

- All cancellations requests must be made in writing. Refunds will be made (excluding your \$600 deposit) according to the following timeline:**
- Cancellations received received prior to April 9, 2027: You will receive 90% of trip price paid to date.**
 - Cancellations received received between April 9, 2027 & June 7, 2027: 85% of trip price paid of trip price paid to date.**
 - Cancellations received between June 8, 2027 & July 7, 2027: 50% of trip price paid of trip price paid to date.**
 - Cancellations received received on or after July 8, 2027: No refund.**

All participants will receive in their confirmation email an "Assumption of Risk / Liability Waiver" form, which must be signed and received 60 days prior to departure, or the reservation will be treated as a cancellation.

CFDM reserves the right to change, modify, or cancel this Pilgrimage prior to departure for any reason. In this case, any payments received will be refunded in full, constituting full settlement. CFDM is not responsible for any additional expenses resulting from a canceled Pilgrimage, such as non-refundable airline tickets.

We strongly suggest the purchase of travel and trip cancellation/interruption insurance, as we cannot make exceptions to our cancellation policy.

CFDM reserves the right to accept, refuse, or decline any Pilgrimage member's participation at any time for any reason. In such a case, liability is limited to the actual cost of the unused services.
